CITY OF RAINBOW CITY-COUNCIL MEETING-APRIL 13, 2020

The City Council of the City of Rainbow City, Alabama, met in regular session at City Hall at 5:00 p.m., and upon roll call by City Clerk, Beth Lee, the following members answered present: Mayor Terry John Calhoun, Anita Bedwell and Rick Hill. Attending via Zoom: Bobby McCartney, Rodney Prickett, and Larry Keenum. The same constituting a quorum of the City Council, the following business was transacted. The meeting was called to order by Mayor Calhoun. Invocation was given by Rodney Prickett. Mayor Calhoun led the Pledge of Allegiance to the flag.
