# STATE OF ALABAMA COUNTY OF ETOWAH

#### **CITY OF RAINBOW CITY- COUNCIL MEETING-AUGUST 28, 2023**

The City Council of the City of Rainbow City, Alabama, met in regular session at City Hall at 5:00 p.m. The invocation was given by Randy Vice. Mayor Taylor led the Pledge of Allegiance to the flag of the United States of America. The meeting was called to order by Mayor Taylor, and upon roll call by City Clerk, Beth Lee, the following members answered present: Anita Bedwell, Randy Vice, Jeff Prince, Jameson Jenkins, Clark Hopper, and Mayor Taylor. The same constituting a quorum of the City Council, the following business was transacted.

- Mayor Taylor presented the minutes of the regular Council meeting of August 14, 2023 and asked if there were any corrections, additions, or deletions. There being none, Jameson Jenkins made a motion to approve the minutes as presented. Jeff Prince seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
- 2. Jeff Prince made a motion to donate \$5,000.00 to the Southside High School Band instrument bus for a wrap-around with Rainbow City's logo. Jameson Jenkins seconded the motion. Mayor Taylor stated all in favor say aye. Randy Vice-Abstain. Mayor Taylor declared the motion carried.
- 3. Mayor Taylor presented a proposal from S&ME for FY2024 MS4 Compliance Services-Rainbow City Municipal Separate Storm Sewer System. Cost is \$12,010.00. Anita Bedwell made a motion to authorize Mayor Taylor to sign the proposal. Jeff Prince seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
- 4. Mayor Taylor presented the following personnel changes:
  - Promote Police Sgt. Andrew Willis to the Narcotics Detective Supervisor effective Friday, September 1, 2023.
  - Post for a certified/non-certified Police Office for ten (10) days to end on Friday,
    September 8, 2023.
  - Officer Parker Riggs started work on Friday, August 18, 2023.
  - Post two (2) full-time Recreation Dept. positions for ten (10) days to end on Friday,
    September 8, 2023

Randy Vice made a motion to accept these personnel changes. Jeff Prince seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.

- 5. Mayor Taylor presented an invoice from the Etowah County Sheriff's Office as reimbursement for Rainbow City hiring Officer Parker Riggs. This reimbursement is for the NE Law Enforcement Police Academy, physical, mental health evaluation, body armor vest, salary (5/8/23-8/11/23), and benefits totaling \$17,890.36. Jameson Jenkins made a motion to approve the payment of this invoice. Jeff Prince seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
- 6. Mayor Taylor presented a request to sell Lot 6A (4.34 acres) in the Deerfoot Industrial Park to Thrasher Investment for the sum of \$34,720.00 and other good and valuable consideration. The transaction would be accomplished by the execution by the City of a corporate warranty deed, subject to any existing easements and restrictive covenants. Jeff Prince made a motion to approve the sale of Lot 6A in the Deerfoot Industrial Park to Thrasher Investments. Jameson Jenkins seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
