The meeting was called to order by Mayor Taylor, and upon roll call by City Clerk, Beth Lee, the following members answered present: Randy Vice, Jeff Prince, Jameson Jenkins, and Mayor Taylor. Anita Bedwell and Clark Hopper-Absent. The same constituting a quorum of the City Council, the following business was transacted.

- Mayor Taylor presented the minutes of the regular Council meeting of December 9, 2024 and asked if there were any corrections, additions, or deletions. There being none, Jameson Jenkins made a motion to approve the minutes as presented. Jeff Prince seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.

- 5. Mayor Taylor presented Resolution No. 24-27 Authorize Mayor Taylor to purchase 24.96 acres at 4026 Steele Station Road for \$570,000.00 to be paid from the General Fund from Michael Wayne Brown, David Albert Brown, and Patrick Richard Brown. Jeff Prince made a motion to adopt Resolution No. 24-27. Jameson Jenkins seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
- 6. Mayor Taylor presented Resolution No. 24-28 Utilize ARPA funds for the renovations to the Rainbow City Municipal Building and 4017 Rainbow Drive (former City Church building). There is \$77,187.00 left in the ARPA checking account. Randy Vice made a motion to adopt Resolution No. 24-28. Jameson Jenkins seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
- 7. Mayor Taylor presented an ad request from The Messenger Progress Edition. Died for lack of a motion.
