## CITY OF RAINBOW CITY- COUNCIL MEETING-JANUARY 8, 2024

The City Council of the City of Rainbow City, Alabama, met in regular session at City Hall at 5:00 p.m. The invocation was given by Anita Bedwell. Mayor Taylor led the Pledge of Allegiance to the flag of the United States of America. The meeting was called to order by Mayor Taylor, and upon roll call by City Clerk, Beth Lee, the following members answered present: Anita Bedwell, Randy Vice, Jameson Jenkins, and Mayor Taylor. Jeff Prince and Clark Hopper-Absent. The same constituting a quorum of the City Council, the following business was transacted.

- 1. Mayor Taylor presented the minutes of the regular Council meeting of December 11, 2023 and asked if there were any corrections, additions, or deletions. There being none, Jameson Jenkins made a motion to approve the minutes as presented. Randy Vice seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
- 2. Mayor Taylor presented the resignation of Police Sgt. Garrett Pentecost effective Friday, January 5, 2024. Anita Bedwell made a motion to accept the resignation and to post for a certified or non-certified police officer for ten (10) days to end on Friday, January 19, 2024.
