The City Council of the City of Rainbow City, Alabama, met in regular session at City Hall at 5:00 p.m. The invocation was given by Clark Hopper. Mayor Taylor led the Pledge of Allegiance to the flag of the United States of America. The meeting was called to order by Mayor Taylor, and upon roll call by City Clerk, Beth Lee, the following members answered present: Anita Bedwell, Randy Vice, Jeff Prince, Clark Hopper, and Mayor Taylor. Jameson Jenkins-Absent. The same constituting a quorum of the City Council, the following business was transacted.

- Mayor Taylor presented the minutes of the regular Council meeting of June 26, 2023 and asked if there were any corrections, additions, or deletions. There being none, Jeff Prince made a motion to approve the minutes as presented. Anita Bedwell seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
- 2. Mayor Taylor stated that sealed bids were opened in pre-council for the surplus items in the Library. One bid was received as follows:

- 6. Mayor Taylor presented the departmental reports from Animal Control, Building, Community Center, Court, Fire, Library, and Police.
- 7. Dr. Phil Baxter, a resident of Rainbow Estates, spoke to the Mayor and Council thanking them for the pickleball courts on Park Lane and stated that the courts were maxed out with players. He had the following concerns: parking being too limited as well as the space between the court and the street, child safety concerns, would like to see the land behind the courts donated to Rainbow City for additional parking, and time limits for players (30 minutes).
