CITY OF RAINBOW CITY- COUNCIL MEETING-JULY 8, 2024

The City Council of the City of Rainbow City, Alabama, met in regular session at City Hall at 5:00 p.m. The invocation was given by Randy Vice. Mayor Taylor led the Pledge of Allegiance to the flag of the United States of America. The meeting was called to order by Mayor Taylor, and upon roll call by City Clerk, Beth Lee, the following members answered present: Anita Bedwell, Randy Vice, Jameson Jenkins, Clark Hopper, and Mayor Taylor. Jeff Prince-Absent. The same constituting a quorum of the City Council, the following business was transacted.

- Mayor Taylor presented the minutes of the regular Council meeting of June 24, 2024 and asked if there were any corrections, additions, or deletions.
