## CITY OF RAINBOW CITY- COUNCIL MEETING-MAY 13, 2024

The City Council of the City of Rainbow City, Alabama, met in regular session at City Hall at 5:00 p.m. The invocation was given by Jeff Prince. Mayor Taylor led the Pledge of Allegiance to the flag of the United States of America. The meeting was called to order by Mayor Taylor, and upon roll call by City Clerk, Beth Lee, the following members answered present: Anita Bedwell, Randy Vice, Jeff Prince, Jameson Jenkins, Clark Hopper, and Mayor Taylor. The same constituting a quorum of the City Council, the following business was transacted.

- Mayor Taylor presented the minutes of the regular Council meeting of April 22, 2024 and special called meeting of May 8, 2024 and asked if there were any corrections, additions, or deletions. Mayor Taylor presented Resolution No. 24-12 – Right of Way for Permanent Easement – Mayor Taylor stated that this was for the bike/pedestrian trail on Kinzie Lane and was a federal requirement for the grant from the State of Alabama.
