CITY OF RAINBOW CITY- COUNCIL MEETING-NOVEMBER 14, 2022

The City Council of the City of Rainbow City, Alabama, met in regular session at City Hall at 5:00 p.m. Invocation was given by Jameson Jenkins. Mayor Taylor led the Pledge of Allegiance to the flag of the United States of America. The meeting was called to order by Mayor Taylor and upon roll call by City Clerk, Beth Lee, the following members answered present: Randy Vice, Jeff Prince, Jameson Jenkins, and Mayor Taylor. Anita Bedwell and Clark Hopper-Absent. The same constituting a quorum of the City Council, the following business was transacted.

- Mayor Taylor presented the minutes of regular Council meeting of October 24, 2022 and asked if there were any corrections, additions, or deletions. There being none, Jeff Prince made a motion to approve the minutes as presented. Jameson Jenkins seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
- 2. Mayor Taylor made a recommendation to reappoint Elizabeth P. Haney as a part-time municipal judge for a 2-year term. Randy Vice moved and Jeff Prince seconded the motion to reappoint Judge Haney. Mayor Taylor asked for a roll call as follows:

- 4. Mayor Taylor had a recommendation to hire Bayleigh Phillips as part-time in the Library effective Friday, November 18, 2022. Jeff Prince made a motion to hire Bayleigh Phillips. Jameson Jenkins seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.

Mayor Taylor presented Resolution No. 22-20A Lease-Purchase Agreement to Leasing 2, Inc. and authorize Mayor Taylor to sign this agreement for terms of 5 years @ \$43,674.18 annual payments for the MowerMax Boom Mower (Ref CM 3/28/22). Jeff Prince moved and Jameson Jenkins seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
- 6. Mayor Taylor presented Resolution No. 22-22 Nuisance Abatement Lien for 5 Horizon Place owned by Bonnie Marshall. The cost of abating the nuisance is \$352.50. Cost is \$470.00 per training session. Jameson Jenkins seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
- 11. Randy Vice made a motion to authorize Mayor Taylor to sign the proposal (22820251) from S&ME for MS4 2022-2023 Annual Report (Separate Storm Sewer System). Cost is \$3,970.00. Jameson Jenkins seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
- 12. Jeff Prince made a motion to authorize Mayor Taylor to sign the proposal (22820261E) from S&ME for Wet-Weather Monitoring FY2023. Cost is \$6,530.00 Jameson Jenkins seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
- 13. Jameson Jenkins made a motion to authorize the City Clerk to request sealed bids for a 2023 Chevrolet Equinox FWD 4DR LS (Administration) and open sealed bids on Monday, November 28, 2022 at 4:30 p.m. Jeff Prince seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
- 14. Jeff Prince made a motion to authorize the City Clerk to request sealed bids for the replacement of a 15-ton gas pack unit at the Recreation Center (4412 Rainbow Drive) to be opened on Monday, November 28, 2022 at 4:30 p.m. Jameson Jenkins seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
- 15. Mayor Taylor presented a recommendation from Chief Yancey for ten (10) FLOCK License Plate Readers to be installed by Alabama Power in Rainbow City. Estimated monthly service will be \$2,291.70 and will include cameras, dedicated 4G LTE network backhaul connection & hardware, all required license fees and monthly subscription fees. Automatically renews for 24 months after month 24. Alabama Power retains ownership of the camera system and the Rainbow City Police Dept. retains ownership of all data collected. Jameson Jenkins made a motion for the FLOCK camera system. Jeff Prince seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
- 16. Randy Vice made a motion to purchase 18 TASER 7's from Axon Enterprises, Inc. for a total price of \$62,100.00 in yearly installments. \$16,499.90 is due December 2022 (to be reimbursed through the Etowah County Community Development Committee

Grant). \$11,399.94 to be paid each December. (Axon is a Sole Source supplier of this product). Jeff Prince seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
