CITY OF RAINBOW CITY-COUNCIL MEETING-OCTOBER 11, 2021

The City Council of the City of Rainbow City, Alabama, met in regular session at City Hall at 5:00 p.m. Invocation was given by Randy Vice. Mayor Taylor led the Pledge of Allegiance to the flag. The meeting was called to order by Mayor Taylor and upon roll call by City Clerk, Beth Lee, the following members answered present: Anita Bedwell, Randy Vice, Jeff Prince, Clark Hopper, and Mayor Taylor. Jameson Jenkins-Absent. The same constituting a quorum of the City Council, the following business was transacted.

- 1. Mayor Taylor presented the minutes of regular Council meeting of September 27, 2021 and asked if there were any corrections, additions, or deletions. There being none, Jeff Prince made a motion to approve the minutes as presented. Anita Bedwell seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Randy Vice made a motion to approve the promotion and posting. Jeff Prince seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
- 5. Mayor Taylor presented a recommendation to appoint Scott Dixon as a new board member of the Greater Etowah 310 Board to replace Amy Tawbush. This appointment has no term limits. Jeff Prince made a motion to appoint Scott Dixon. Anita Bedwell seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
