CITY OF RAINBOW CITY-COUNCIL MEETING-OCTOBER 8, 2018

The City Council of the City of Rainbow City, Alabama, met in regular session at City Hall at 5:00 p.m., and upon roll call by City Clerk, Beth Lee, the following members answered present: Mayor Terry John Calhoun, Anita Bedwell, Tim Ramsey, Larry Keenum, and Rick Hill. Bobby McCartney-absent. The same constituting a quorum of the City Council, the following business was transacted. The meeting was called to order by Mayor Calhoun. Invocation was given by Larry Keenum. Mayor Calhoun led the Pledge of Allegiance to the flag.

- Mayor Calhoun presented the minutes of regular Council Meeting of September 24, 2018 for review, and asked if there were any corrections, additions, or deletions. There being none, Anita Bedwell made a motion to approve the minutes as presented. Tim Ramsey seconded the motion. Mayor Calhoun stated all in favor say aye. All ayes. Mayor Calhoun declared the motion carried.
- 2. Mayor Calhoun stated that bids were opened in Pre-Council at 4:30 p.m. for the surplus items in the Library and Shop. One bid was received for the Library-Gary Ragsdale bid \$126.00. Two bids were received for the Shop-Gary Wilson bid \$250.00 and Huey Woodard bid \$225.00. Rick Hill moved to award the bids to Gary Ragsdale and Gary Wilson. Larry Keenum seconded the motion. - 4. Mayor Calhoun presented a request to hire Joel Garmon as Planning Coordinator in the Building Department to start Friday, October 19, 2018 at \$19/hr. with family coverage insurance. - 8. Mayor Calhoun presented a request for a Library Board appointment. Rick Hill moved to appoint Jerry Tolbert to serve a 4-year term effective November 1, 2018. Anita Bedwell seconded the motion. Mayor Calhoun stated all in favor say aye. All ayes. Mayor Calhoun declared the motion carried.
- Mayor Calhoun stated two (2) Utility Board appointments end on October 11, 2018. Anita Bedwell moved to appoint Nick Hall and Keith Raines to a 6 year term. Rick Hill seconded the motion. Mayor Calhoun asked the clerk to call the roll as follows: Anita Bedwell-Yes, Bobby McCartney-absent, Tim Ramsey-No, Larry Keenum-Abstain, Rick Hill-Yes, Mayor Calhoun-Yes. Mayor Calhoun declared the motion carried.
