CITY OF RAINBOW CITY- COUNCIL MEETING-AUGUST 22, 2022

The City Council of the City of Rainbow City, Alabama, met in regular session at City Hall at 5:00 p.m. Invocation was given by Jeff Prince. Mayor Taylor led the Pledge of Allegiance to the flag of the United States of America. The meeting was called to order by Mayor Taylor and upon roll call by City Clerk, Beth Lee, the following members answered present: Anita Bedwell, Randy Vice, Jeff Prince, Clark Hopper and Mayor Taylor. Jameson Jenkins-Absent. The same constituting a quorum of the City Council, the following business was transacted.

1. Mayor Taylor presented the minutes of regular Council meeting of August 8, 2022 and asked if there were any corrections, additions, or deletions. There being none, Clark Hopper made a motion to approve the minutes as presented. Jeff Prince seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.

6. Mayor Taylor had a recommendation to hire Andrew Hughes as a Business License Inspector effective Friday, August 26, 2022. Jeff Prince made a motion to hire Andrew Hughes. Anita Bedwell seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
7. Mayor Taylor made the recommendation to surplus the 2008 Ford DRW Super from the Fire Dept. and sell to the Town of Steele for \$17,000.00. Randy Vice made the motion surplus this vehicle and sell to the Town of Steele. Jeff Prince seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
8. Mayor Taylor presented a contract with MCCI (Laserfiche) for electronic document subscription and records management configuration for \$32,240.95 with \$13,322.00 of this in recurring annual subscription/support. Anita Bedwell made a motion to allow Mayor Taylor to sign the contract. Clark Hopper seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
9. Mayor Taylor presented Resolution No. 22-16 – Comprehensive (Master) Plan. Jeff Prince made a motion to adopt Resolution No. 22-16. Anita Bedwell seconded the motion. Mayor Taylor asked for a roll call as follows:
