CITY OF RAINBOW CITY-SPECIAL COUNCIL MEETING-MARCH 23, 2023

The City Council of the City of Rainbow City, Alabama, met in special session at City Hall at 4:00 p.m. The meeting was called to order by Mayor Taylor and upon roll call by Acting City Clerk, Cindy Posey, the following members answered present: Anita Bedwell, Randy Vice, Jeff Prince, and Mayor Taylor. Jameson Jenkins and Clark Hopper-Absent. A public notice was posted on March 17, 2023. The same constituting a quorum of the City Council, the following business was transacted.

1. Cindy Posey opened sealed bids for the 2019-2021 used transit/cargo van. The bids were as follows:

Town & Country Ford – 2020 Ford Transit Van	\$40,504.50
Woody Anderson Ford – 2021 Ford Transit Van	\$39,066.00
Alexander Ford, Inc. – 2019 Ford Transit Van	\$34,411.50

Anita Bedwell made a motion to purchase the 2019 Ford Transit Van from Alexander Ford, Inc. for \$34,411.50. Randy Vice seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.

2. Mayor Taylor stated that the bids for the (previous) 2023 Resurfacing Project was scheduled to be opened at today's meeting but for the lack of competitiveness in the specs, this bid has been cancelled. All vendors were notified via email of the cancellation. Specs have now been revised and split into two (2) separate projects. 2023 Spring Micro-Surfacing and 2023 Spring Resurfacing Project. Sealed bids for these two (2) projects will be opened at 4:30 p.m. on Monday, April 10, 2023 in Council Chambers.
3. Mayor Taylor announced that Rainbow City was awarded the ATRIP II project(#ATRP2-28-2-23-418) from the State. Anita Bedwell moved and Jeff Prince seconded the motion to authorize Mayor Taylor to sign the preliminary engineering and construction agreement between the State of Alabama and the City of Rainbow City for access management on SR-77 from Church St. to Sherwood Dr., including new traffic signal, resurface Church St., from US-411 to SR-77. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
4. Mayor Taylor presented Resolution No. 23-05 – Agreement for Cooperative Maintenance on State Route-25 (Rainbow Drive) at Morgan Crossing Subdivision. Anita Bedwell made a motion to adopt Resolution No. 23-05. Jeff Prince seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.

There being no further business to come before the Council, Anita Bedwell made a motion to adjourn. Jeff Prince seconded the motion. Time Adjourned: 4:11 p.m.
