CITY OF RAINBOW CITY- COUNCIL MEETING-JUNE 12, 2023

The City Council of the City of Rainbow City, Alabama, met in regular session at City Hall at 5:00 p.m. The invocation was given by Randy Vice. Mayor Taylor led the Pledge of Allegiance to the flag of the United States of America. The meeting was called to order by Mayor Taylor, and upon roll call by City Clerk, Beth Lee, the following members answered present: Randy Vice, Jeff Prince, Jameson Jenkins, Clark Hopper, and Mayor Taylor. Anita Bedwell-Absent. The same constituting a quorum of the City Council, the following business was transacted.

1. Mayor Taylor presented the minutes of the regular Council meeting of May 22, 2023 and asked if there were any corrections, additions, or deletions. There being none, Jeff Prince made a motion to approve the minutes as presented. Jameson Jenkins seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. 4. Mayor Taylor presented a request to purchase a 2023 Polaris (R23CDA57A1) Ranger Crew 570 for \$17,557.00 from Greenville Equipment Center. Sourcewell Contract (buying cooperative) contract #122220-PSI. Jameson Jenkins made a motion to purchase the Polaris for the Police Dept. Jeff Prince seconded the motion. 5. Jeff Prince made a motion to authorize Mayor Taylor to sign the Consulting Agreement between Jason Harper and Rainbow City for \$3,000.00 per month for advocacy work. 9. Mayor Taylor presented Resolution No. 23-14 – Nepotism Policy which will become a part of the employee handbook Section 4.13. Jameson Jenkins made a motion to

10. Mayor Taylor presented Resolution No. 23-15 – Expend funds from the Opioid Settlement Account to Maximizing Mental Health, Inc. This is an approved use of funds (mental health).
