CITY OF RAINBOW CITY- COUNCIL MEETING-MARCH 25, 2024

The City Council of the City of Rainbow City, Alabama, met in regular session at City Hall at 5:00 p.m. The invocation was given by Clark Hopper. Mayor Taylor led the Pledge of Allegiance to the flag of the United States of America. The meeting was called to order by Mayor Taylor, and upon roll call by City Clerk, Beth Lee, the following members answered present: Randy Vice, Jeff Prince, Jameson Jenkins, Clark Hopper and Mayor Taylor. Anita Bedwell-Absent. The same constituting a quorum of the City Council, the following business was transacted.

1. Mayor Taylor presented the minutes of the regular Council meeting of February 26, 2024 and asked if there were any corrections, additions, or deletions. There being none, Randy Vice made a motion to approve the minutes as presented. Jeff Prince seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
2. Jameson Jenkins moved to authorize Mayor Taylor to sign the Pixis Drones, LLC agreement for the drone light show scheduled for June 29, 2024. The show will last 20 minutes. Jeff Prince seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
3. Mayor Taylor presented the following personnel changes:
 - Post a full-time Municipal Court Social Worker position for ten (10) days to end on Friday, April 5, 2024
 - Hire Garrett Johnson as a full-time uncertified police officer effective Friday, March 29, 2024
 - Hire Hayley Daniel as a full-time Animal Shelter Technician, effective Friday, April 12, 2024Clark Hopper made a motion to approve these personnel changes. Randy Vice seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
4. Mayor Taylor stated the FY2023 audit was completed and would be posted on the website. Jeff Prince made a motion to accept the FY2023 audit as presented. Jameson Jenkins seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
5. Jameson Jenkins made a motion to purchase 22 Remington Less Lethal Shotguns with saddles and slings from Craig's Firearm Supply, Inc. for \$14,415.00. Rainbow City has been awarded a grant by the Etowah County Community Development Block Grant District 28 for \$14,000.00. Jeff Prince seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.
6. Mayor Taylor presented Ordinance No. 587 – Rezone 661 Sutton Bridge Road from Highway Commercial District (HC) to Manufacturing District (M-1). Mayor Taylor stated this was the time for a Public Hearing and anyone was present who wished to speak for or against the rezoning. Rachel White-109 Riverview Lane- spoke in favor of the rezoning due to the specialized jobs and robotics this new business would require. Barry Hill-83 Guy Hood Road spoke in favor of the rezoning. No one was present to speak against the rezoning. Jameson Jenkins made a motion to introduce the ordinance. Randy Vice seconded the motion. Mayor Taylor declared the motion carried. Jeff Prince moved and Clark Hopper seconded the motion to suspend the rules for immediate consideration. Mayor Taylor asked for a roll call as follows:

7. Mayor Taylor presented Ordinance No. 588 – Establishing the Salary for the Mayor (\$75,000.00 annually) and City Council (\$1,250.00 monthly) effective November 3, 2025. Jameson Jenkins made a motion to introduce the ordinance. The last pay increase for the Mayor and Council went into effect in October 2000. Jeff Prince seconded the motion. Mayor Taylor declared the motion carried. Jeff Prince moved and Jameson Jenkins seconded the motion to suspend the rules for immediate consideration. Mayor Taylor asked for a roll call as follows:

8. Mayor Taylor presented Resolution No. 24-05 – Absolute Respiratory Care Economic Development Agreement. City to abate sales tax on any construction related materials purchased within the city limits during construction of the new facility, Rainbow City to grant 100 loads of site prep material from the City's owned chert pit during construction of the new facility and grant a rebate of one-half (50%) of the City's portion of non-educational property taxes not to exceed 2 years. Mayor Taylor stated that this was a time for a public hearing. No one was present to speak for or against. A public notice was published in The Messenger newspaper on Friday, March 15, 2024.

Randy Vice made a motion to approve Resolution No. 24-05. Jeff Prince seconded the motion. Mayor Taylor asked for a roll call as follows:

Clark Hopper made a motion to approve Resolution No. 24-06. Jeff Prince seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.

10. Mayor Taylor presented Resolution No. 24-08 – Authorizing the Retention of Counsel to file and prosecute a claim and/or action against Greg and Amanda Barnard and Superman Tree Service arising from the failure to abate a public nuisance located at 545 Sunset Drive. Jameson Jenkins made a motion to approve Resolution No. 24-08. Jeff Prince seconded the motion. Mayor Taylor stated all in favor say aye. All ayes. Mayor Taylor declared the motion carried.

11. Mayor Taylor presented Resolution No. 24-09 – Purchase 4017 Rainbow Drive from City Church for \$1,175,000.00. Jeff Prince made a motion to approve Resolution No. 24-09. Jameson Jenkins seconded the motion. Mayor Taylor asked for a roll call as follows:

14. Mayor Taylor presented the departmental reports from Animal Control, Building, Community Center, Court, Fire, Library and Police.


